Maniapoto Netball Centre COVID-19 Management Plan 2022

UPDATED: 12 April 2022

General Information

- 1. Under the COVID-19 Protection Framework (CPF) organisations are required to meet set requirements to help protect Members, Participants, Spectators, Staff and Workers from COVID-19. Maniapoto Netball Centre operates under the requirements for Community Sport Gatherings and Events.
- 2. Each setting has requirements, restrictions, and guidelines which as a sport, and as a centre, we must follow. The requirements for Community Sport at each level of the CPF can be found on the Sport NZ website www.sportnz.org.nz. The requirements, restrictions and guidelines are set and can be changed at any time by the following bodies. There may also be other bodies who set requirements, restrictions, and guidelines.

 - Netball Waikato Bay of Plenty

- 3. Failure by the Centre and any person within the Centre, to follow the requirements and restrictions set, means that the Centre can be shut down at any time.

Definitions

Definitions listed below are for the purpose of this policy. Definitions in other Maniapoto Netball Centre policies may differ.

Centre is defined as the area on Te Kūiti Road, Te Kūiti within the netting fence surrounding the netball courts and the Pavilion.

Member is any person who is registered with any team for a competition, programme, or event with Maniapoto Netball Centre. This includes players, umpires, coaches, managers, officials, course participants, programme participants, event participants.

Member may be extended to and include any person for whom personal information is provided as part of membership i.e. parents/caregivers and emergency contacts, if those people enter our Centre

Participant is any person who takes part in bookings or other programmes who is not registered through the Maniapoto Netball Centre member database, if those people enter our Centre.

Spectator includes any person whether connected to a member or otherwise who is authorised to enter our Centre to spectate for any reason.

Staff includes any person who is in a paid position as an employee, at Maniapoto Netball Centre. **Work** includes any work or duties undertaken by a worker at

Worker includes any contractors, volunteers, officials, umpires, coaches or any other person who has duties or work at Maniapoto Netball Centre.

Work Plan

This management plan is put in place to address the following areas:

1. Managing the risks of operating in the current COVID-19 environment

- 2. Keeping workers safe and well
- 3. Keeping members, participants, spectators and the public safe
- 4. Monitoring effectiveness of controls
- 5. Impact on risks of operating in the current environment

Operating under the CPF

While operating under the CPF, Maniapoto Netball Centre will:

- 1. Ensure any workers who enter the Centre are well and able to work.
- 2. Ensure any workers who enter the Centre are provided information on and understand the requirements for working under the CPF.
- 3. Promote:
 - o Unwell people do not come into the centre.
 - Physical distancing is always observed as per the requirements for each traffic light setting.
 - o Mask wearing determined from the current traffic light setting

Measures under the COVID Protection Framework

My Vaccine Pass

Our protocols for MVP:

Numbers and Physical Distancing

The number permitted for community sport will be capped as per the requirements for the particular traffic light setting at the time and for the defined spaces available at the centre.

In general for Maniapoto Netball Centre:

Red	200 per defined area	1. When entering the pavilion you MUST wear a mask
Orange	No limits	 No limits on outdoor gatherings It is strongly encouraged you wear a mask when entering the pavilion
Green	No limits	1. The Centre as a whole becomes the defined area

Cleaning and Hygiene

Maniapoto Netball Centre will meet the requirements for community sport for cleaning and hygiene to the extent possible and practicable.

Our Cleaning and Hygiene Protocols

- 1. All bathrooms will have hand washing facilities. Sanitiser will be provided in key areas around the facility and encouraged to be used by all members, teams and by individual participants.
- 2. The Centre and any equipment used that can be cleaned, will be disinfected with an appropriate anti-viral disinfectant that kills viruses and bacteria at least once a day when the centre is in use.
- 3. Workers are responsible for cleaning their workstations.
- 4. Information is to be sent out explaining the importance that no one is allowed to participate or be within the Centre who is showing signs of illness of any kind or who is required to be in isolation due to their exposure or potential exposure to COVID-19. Posters continue to be displayed outlining important COVID-19 health information.

Ventilation

Where practicable Maniapoto Netball Centre will ensure adequate ventilation in the Pavilion to help reduce possible transmission of the virus.

Our protocols for Ventilation:

- o Open doors to the courtside
- Open main hall door
- Open windows and doors upstairs, if in use

The above ventilation measures will be weather dependent.

Face Coverings

When setting requirements for face coverings Maniapoto Netball Centre will consider the requirements for:

- Community sport
- Public facing businesses
- Indoor facilities

Our protocols for Face Coverings

Maniapoto Netball Centre will provide information on requirements for wearing face coverings for anyone who shall enter the inside of the Pavilion.

Face coverings will be worn as directed by the Ministry of Health. If not specified:

 Face coverings are strongly encouraged to be worn whilst inside the pavilion by all Members, Participants, Spectators, Staff and Workers.
